EXPENSE REIMBURSEMENT

Only expenses necessary to the purpose of the travel shall be reimbursable.

EXPENSE REIMBURSEMENT REGULATION

The district shall reimburse district employees, officials and members of the

Board of Education for reasonable, actual and necessary out-of-pocket expenses incurred while traveling for school-related business upon receipt of a completed voucher with itemized receipts along with an approved Absence Approval Request

form and proof of attendance. The following rules shall guide the reimbursement of school-related travel expenses:

Transportation

- Travel shall be by the most economical method, whether by private automobile, school vehicle or common carrier such as bus, train or plane.

Meals

Reimbursable meal charges, including gratuities, for persons traveling for district-related business shall be as follows:

• Breakfast \$12.00

• Dinner \$43.00

OR

• Lunch \$12.00

Personal Expenses

The district does not reimburse persons traveling on district-related business
